- I. **Application Process:** All Eligible candidates, who wish to appear for walk-in-interview, may report in person at Committee Room adjacent to Office of Director, AIIMS New Delhi for verification / Walk-In-Interview on 26th to 27th June, 2018 between 9:00 AM to 10:00 AM along with prescribed proforma with all original documents as mentioned in advertisement.

candidates reporting after 10:00 AM, will not be allowed to appear in verification / walk-in-interview.

applicants should carry their complete application form sign it and bring it along with originals and attested photocopies of following certificates in Walk-In-Interview.

- II. **Site of Interview:** Interviews will be held at Committee Room adjacent to Office of Director, AIIMS, New Delhi. No TA/DA will be paid to candidates appearing for interview.

III. **Essential Qualification:**

Essential for medical candidates (for General Discipline)

1. A medical qualification included in I or II schedule or part II of third schedule to Indian medical council Act of 1956 (Persons possessing qualifications included in part II of third schedule should also fulfill condition specified in section 13(3) of Act.)
2. D.M. in respective discipline/subject for medical super specialties and M.Ch. in respective discipline/subject for surgical super specialties (2 years or 3 years or 5 years recognized course) Or a qualification recognized equivalent thereto.

Experience (as on 31.12.2018):

Three years teaching and/or research experience in experience in a recognized institution in subject of specialty after obtaining qualifying degree of M.D. /M.S. Or a qualification recognized equivalent thereto.

Essential for super specialty disciplines: -

1. A medical qualification included in I or II schedule or part II of third schedule to Indian medical council Act of 1956 (Persons possessing qualifications included in part II of third schedule should also fulfill condition specified in section 13(3) of Act.)
2. D.M. in respective discipline/subject for medical super specialties and M.Ch. in respective discipline/subject for surgical super specialties (2 years or 3 years or 5 years recognized course) Or a qualification recognized equivalent thereto.

Experience (as on 31.12.2018):

One year teaching and/or research experience in a recognized institution in subject of specialty after obtaining qualifying degree of D.M./M.Ch. (2 years or 5 years recognized course after MBBS) or qualification recognized equivalent thereto. However, no experience is necessary for candidates possessing 3 years recognized degree of D.M./M.Ch or qualification recognized equivalent thereto.

Essential for Non- Medical Candidates-

1. Post graduate qualification e.g. Masters degree in discipline/ allied subject
2. A doctorate degree of recognized university

Experience (as on 31.12.2018):

Three years teaching and/or research experience in discipline/subject concerned after obtaining doctorate degree.

TERMS AND CONDITIONS FOR CONTRACT APPOINTMENT FOR FACULTY POSTS

1. Appointment is purely on CONTRACT BASIS for a period of one year or till such time alternate arrangements are made, whichever is earlier, with effect from date of joining. However, contractual appointment shall not be extended beyond period of two years. If contract is not extended further, same will lapse automatically. Appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete period of three months to satisfaction of competent authority.
2. Remuneration for post of Assistant Professor will be Rs.1,30,000/- (Rupees One Lakh Thirty Thousand Only) per month (Consolidate) approximately.
3. Appointee shall perform duties as assigned to him/her. Competent authority reserves right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
4. Appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to Government Servants, appointed on regular basis.
5. Appointee shall not be granted any claim or right for regular appointment to any post of AIIMS, Rishikesh.
6. Appointee shall be on whole time appointment of AIIMS Rishikesh and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during period of contract.
7. Appointment to said post will be subject to medical fitness from competent medical board for which he/she will be sent to designated Medical Authority.
8. Leave entitlement of appointee shall be governed in terms of instructions contained in DoPT&T's O.M. No.12016/3/84-Estt.(L) dated 12th April, 1985 as amended by OM No. 12016/1/96-Estt(L) dated 5th July, 1990.
9. On appointment, appointee will be required to take an oath of allegiance to Constitution of India or make a solemn affirmation to that effect in prescribed proforma.
10. Appointee is not entitled to any T.A. for attending interview and joining appointment.
11. Other conditions of service will be governed by relevant rules and orders issued from time to time.
12. If any declaration given or information furnished by him/her proves false or if he/she is found to have willfully suppressed any material, information, he/she will be liable for removal from service and also such other action as Government may deem necessary.
13. Appointee shall not be entitled to avail any allowances/facilities being extended to regular/permanent faculty members of AIIMS, Rishikesh.
14. AIIMS, Rishikesh reserves rights to increase or decrease number of vacancies.
