ESSENTIAL QUALIFICATION:

A postgraduate medical degree viz. MD/DNB or a Diploma in the concerned specialty from a recognized University / Institution (preference will be given to MD/DNB candidates).

Note: Candidates who have already completed / done three years of Senior residency will be not considered.

UPPER AGE LIMIT AS ON THE DATE OF WALK-IN-INTERVIEW: Senior Residents: 33 years.

- (i) Relaxable for SC/ST candidate up to a maximum period of 05 years, and in the case of OBC candidates up to a maximum period of 03 years.
- (ii) In the case of Orthopedic Physical Handicapped (OPH) candidates, relaxable upto maximum period of 10 years for General Category, 13 years for OBC category and 15 years for SC/ST category candidates.
- (iii) Reservation for SC/ST/OBC/OPH shall be applicable as per Govt. of India rules.
 - OBC Candidates will attach certificate from the prescribed authority for Central Government posts along with certificate that the candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than one year of date of Walk-in-Interview.
 - For SC/ST Candidates Certificate should be issued by Tehsildar or above rank officer in standard format of Central Government.

OPH Candidates – The disability certificate should be signed by duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions & countersigned by Medical Superintendent. The constitution of the Medical Board will be one consultant each from disciplines of Orthopedics, Physical Medicine & Rehabilitation and Surgery.

SELECTION PROCEDURE

The selection will be on the basis of the written examination/interview. The list of selected candidates will be uploaded on website. Candidates are advised to check the Institute website regularly for information.

The Candidate should bring following original documents and one set of self-attested photocopies at the time of Interview with application form:-

TERMS & CONDITIONS

1. <u>Tenure:</u> - The tenure for the posts of Senior Residents shall be initially for 11 months or till regular Senior Resident join the Institute whichever is earlier. The total duration of SR Ship cannot be beyond 3 years as per Residency Scheme, in any circumstances (Adhoc-Regular), including the duration of residency already rendered by the applicant in any hospital of govt. / public sector undertaking / autonomous bodies funded by the govt. prior to this appointment, if any.

2. <u>Salary</u>: - The appointee will be entitled to salary as mentioned in the advertisement or as amended by the Government from time to time.

3. <u>Leave:</u> - The leave entitlement of the appointee shall be as per Residency Scheme and Institute's policy as amended from time to time.

4. <u>Expiry of Appointment:</u> Appointment can be terminated at any time by the Institute by giving one month notice or salary in lieu thereof. The employee can also leave the Institute by giving one month notice or salary in lieu thereof. The appointment shall be terminated immediately on the basis of unsatisfactory work or continued absence or on disciplinary grounds. If termination of service is made on the basis of unsatisfactory work or due to continued absence of the appointee or on the disciplinary grounds, then he/she will not be entitled for any salary in lieu of notice period.

5. The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.

6. The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.

7. This appointment is whole time and private practice of any kind is prohibited. He / She will have to work in shifts and can be posted at any place in the Institute.

8. He / She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.

9. No travelling or other allowances will be paid to the candidate for joining the post.

10. The candidate should not have been convicted by any Court of Law.

11. Canvassing in any form will render the candidate disqualified for the post.

No individual intimation will be sent by AIIMS Rishikesh to applicants.
