1.Terms & Conditions:

- A. The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible.
- B. Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signingof quotation by the authorized representative letter of authorization must be attached with the quotation.
- C. Rates must be quoted as per the format specified Taxes extra if any must be written separately.
- D. Rates must be quoted FOR basis (including Freight charges, Insurance etc.)
- E. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- F. The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- G. Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.

- I. The latest / revised edition shall be supplied. Certificate stating that latest edition of Books (Indian & Foreign) is quoted must be submitted by the Bidder.
- J. The suppliers shall replace free of charge any defective book supplied by them due to faulty printing or pagination, soiled copy or any other reason.

- K. RTGS/NEFT details need to be furnished by the supplier with the quotation on the letter head of supplier/firm/agency.
- L. The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:
 - Firm shall be registered with the Government of Uttarakhand / Central Government.
 - The firm shall have valid VAT/ Sales Tax No. and IT PAN.
 - The firm should not be black listed by any Govt. Agency/Dept.
